- 3. **PATRICK BYRNE, PhD** Now Professor Emeritus, Philosophy Department, Boston College, he was a member since 1975, and served as chairman from 2003-2010. He directed BC's Lonergan Institute since 2011. The associate director of the Jesuit Institute from 1997-2001, Byrne also was a member of the University Core Development and Core Renewal committees. His latest book, The Ethics of Discernment, was published in 2016.
- 4. TRACY REGAN -Professor of the Practice at Boston College. She completed all of her degrees at the University of Arizona--she has a B.A. in Economics, a B.S. in Mathematics, a M.A. in Economics, and a Ph.D. in Economics. She spent 8 years at the University of Miami as an Assistant Professor. She returned to the University of Arizona for 2 years. She joined the Department of Economics at BC in 2013. Regan is an applied microeconomist with specialties in Health Economics, Labor Economics, and Industrial Organization. She regularly teaches the 300-person Principles of Economics class, along with other courses in her area of study. ATM Project: "Social and Economic Determinants of Health Care and Utilization: The Powers of Observation". The ATM project corresponds to a class I taught abroad for the first time in summer of 2019, learning about and comparing the health care systems in France, the UK, and the US. In addition to understanding the history, the politics, and the funding sources the students were provided a first-hand experience in understanding how social determinants of health care matter and reveal themselves. A series of reflection essays were assigned that asked about students' biases, experiences, insights, and judgments.
- 5. **KAREN ARNOLD**, Ph.D. is Professor of Higher Education at Boston College. A pioneer in research on "summer melt," she is the author of books and articles in the fields of college access, talent development, and the use of technology in college advising. Her books include "The Ecology of College Readiness," and "Lives of Promise: What Becomes of High School

Valedictorians." Her work has been funded by the U.S. Department of Education (IES), the Spencer, Hewlett, and Mellon Foundations, and Bloomberg Philanthropies.

- 8. **GENEVIEVE PINTO ZIPP -** PT, EdD, FNAP is a Professor at Seton Hall University in the School of Health and Medical Sciences, Department of Interprofessional Health Sciences and Health Administration. Dr. Pinto Zipp serves as the Director, for the Center for Interprofessional Education in Health Sciences, Acting Program Director for the PhD in Health Sciences and is a GEM Fellow, SHU Center for Vocation and Servant Leadership and the Center for Catholic Studies. In 2018, Dr. Pinto Zipp was inducted as a Distinguished Scholar and Fellow of the National Academies of Practice (NAP).
