# ATTENTION NFL: WOMEN ARE FOLLOWING YOUR CONTROVERSIES AS CLOSELY AS MEN

# Support for Goodell Drops; Rises for Obama's Position on 'Thinking Twice About Having a Son Play'

S. Orange, NJ, October 9, 2014 — A poll by the Seton Hall Sports Poll this week finds that the current NFL controversies - domestic violence and concussions - have garnered the attention of the nation's women in equal or higher numbers than men.

66% of women say they are following the domestic violence issue either somewhat closely or very closely, compared to 63% of men. On the issue of concussion injuries, 53% of women are following the story compared to 57% of men.

It is unusual for women to be as interested as men in sports. These levels are much higher than the 50% of women that closely follow sports and lower than the 69% of men that closely follow sports.

The poll, conducted over three days and concluding last night, was based on random phone calls to land lines and cellphones across the U.S. to 968 people, with a +/- 3% margin of error.

The domestic violence issue is being followed by both men and women in far greater numbers than the concussion story (nearly 2-1), and both groups disapprove of the way the NFL has dealt with reports about players involved in cases of domestic violence. 51% of all respondents disapprove (53% women, 49% men), and only 22% approve (20% women, 24% men).

"The NFL greatly values its women fan base, and the issue of domestic violence was really an attention getter for them," noted Rick Gentile, director of the poll, which is sponsored by The Sharkey Institute.

#### **OPINION OF GOODELL TANKS**

Commissioner Roger Goodell's standing has taken a hit as well, with only 12% offering a favorable view of him, compared to 23% unfavorable and 54% having no opinion. When asked to measure his performance in a Seton Hall Poll in October 2013, only 14% had an unfavorable view; 27% viewed him favorably. (59% had no opinion). In September 2011, only 7% viewed him unfavorably, with 28% viewing him favorably

On the matter of the NFL doing enough to protect its players from concussions and head injuries, 34% said yes it is, but 41% said no, it isn't. When asked the same question in October, 2012, the Seton Hall Sports Poll found 44% saying yes, and 39% saying no.

# SUPPORT FOR OBAMA'S POSITION

On a question revisiting President Obama's statement about "having to think twice about having a son play football", only 30% now disagree with him. In a similar question based on the quote, asked by the Seton Hall Sports Poll in January 2013, 67% in effect disagreed with him saying they would let their son play.

## About the poll:

This poll was conducted by telephone October 6-7-8, 2014 among 968 adults in the United States. The Seton Hall Sports Poll is conducted by the Sharkey Institute.

Phone numbers were dialed from samples of both standard landline and cell phones. The error due to sampling for results based on the entire sample could be plus or minus 3.9 percentage points. The error for subgroups may be higher. This poll release conforms to the Standards of Disclosure of the National Council on Public Polls.

The Seton Hall Sports Poll has been conducted regularly since 2006.
