Seton Hall Sports Poll Examines Athlete Popularity

ONE YEAR LATER, FEELINGS ON TIGER WOODS ARE SPLIT; Peyton Manning Enjoys Tremendous Favorable Rating

29% Favor Fine, Suspension After Unnecessary Roughness Call; Fans Embrace NFL Replays in Settling Close Calls

S. Orange, NJ, November 18, 2010 – One year after Tiger Woods' life changed following an auto accident in front of his Florida home, his popularity rating is evenly split among Americans, with 40% reacting to him unfavorably and 39% favorably.

By comparison, Indianapolis quarterback Peyton Manning, featured in a "good guy" role in many television commercials, has a 65% favorable score compared to only 4% unfavorable.

The results emerged in a poll conducted this week by the Seton Hall Sports Poll of 770 Americans (with a margin of error of plus/minus 3.6%). The random dial poll across all regions of the country also gave LeBron James a 40% favorable showing to 16% unfavorable, and 49% favorable to 19% unfavorable for Brett Favre.

"Forty percent unfavorable for Tiger clearly shows work to be done on his image," noted Rick Gentile, director of the Seton Hall Sports Poll, conducted by The Sharkey Institute. "But knowing the American capacity for forgiveness and how winning can turn people's opinions around, we wouldn't be surprised to see a few early season wins tip this in a more favorable direction."

Among men Tiger Woods scores 52% favorable vs. 30% unfavorable, while among women, the divide is 27% vs. 50%.

Among other athletes listed in the questionnaire, Phil Mickelson was 45-6%, (favorable vs. unfavorable), Derek Jeter 50-8%, Kobe Bryant 49-21%, and Barry Bonds 23-34%.

Fans Like Replays; Favor Fines and Suspensions for Rough Hits; Replays Show Acceptance and Popularity in Making Calls

An overwhelming majority of respondents – 65% - thought that the use of replays by the NFL has enhanced their enjoyment of the game, with only 14% feeling it detracts.

Fifty-six percent favor Major League Baseball using replays in a manner similar to the NFL, with only 22% opposing.

On the question of unnecessary roughness, 29% favored a fine and suspension, 16% said just a fine, 19% said ejection from the game was sufficient, and 20% thought a 15-yard penalty was appropriate.

"We haven't asked the question before," noted Gentile, "but it's become a hot button issue for the NFL and fans seem divided on tough versus lenient action by the league on it."

The poll also asked whether viewers would rather watch a regular season NFL game or a World Series game, and 50% chose the NFL game as opposed to just 31% for a World Series.
