PUBLIC DISAGREES WITH NBA COMMISSIONER SILVER'S ADVOCACY OF SPORTS BETTING, BUT AGREES WITH HIS POSITION

S. Orange, NJ, November 20, 2014 --- While the majority of Americans agree that gambling has become a popular form of entertainment, and that it should be legal to bet on sports, they don't think it was appropriate for NBA Commissioner Adam Silver to take such a stance.

While 55% agreed with Silver and 33% disagreed that it should be legal to bet on sports, by almost the same margin, 51%-34%, the public thinks that it was inappropriate for the Commissioner to take such a stance. And while they don't approve of his advocacy, the vast majority, 72%-20%, agree with him that gambling has become a popular form of entertainment.

The poll, conducted by the Seton Hall Sports Poll over three days and concluding last night, was based on random phone calls to land lines and cellphones across the US to 847 people, with a +-3.4% margin of error.

Broken down by gender, 44% of males and 25% of females supported Commissioner Silver's stance, with 44% of males also not in support and 58% of females not in support. Younger people supported him more than older ones, with support of 47% (age 18-29), 35% (30-44), 30% (45-59) and 26% (60+).

DISTURBING AMOUNT THINK GAME RESULTS ALREADY INFLUENCED BY GAMBLING

Even without legalized gambling in place, the public suspects all is not clean with game results. 47% of Americans believe referees or umpires influence the outcomes of games occasionally or often because of gambling interests, and 43% believe athletes influence the outcomes occasionally or often because of gambling interests. Only 38% (re: officials) and 37% (re: athletes), believe they never, or very rarely, influence outcomes.

"Those are shockingly high numbers," noted Rick Gentile, director of the poll, which is sponsored by The Sharkey Institute. "The leagues can't take this lightly when the very integrity of their sports is a prime responsibility. And it must be part of any discussion of legalized sports betting."

Indeed, 49% felt that legalized sports gambling would damage the integrity of sports, with 44% saying it would not.

NATION AGREES WITH NEW JERSEYANS ON BILL SUPPORTING SPORTS GAMBLING

A Seton Hall Sports Poll last month asked residents of New Jersey whether they supported a bill allowing sports gambling in their state, and 52% agreed, with 37% opposing it. The same question was asked of a national sample this week and similar results were returned - 50% in support, and 39% opposing. Indeed 61% of the nation felt it should be left to the states, with only 29% saying it was a matter for the federal government.

About the poll:

This poll was conducted by telephone November 17-19, 2014 among 847 adults in the United States. The Seton Hall Sports Poll is conducted by the Sharkey Institute.

Phone numbers were dialed from samples of both standard landline and cell phones. The error due to sampling for results based on the entire sample could be plus or minus 3.4 percentage points. The error for subgroups may be higher. This poll release conforms to the Standards of Disclosure of the National Council on Public Polls.

The Seton Hall Sports Poll has been conducted regularly since 2006.
