SUMMARY OF EXPERIENCE

Dr. Andrea Bartoli is a leader of academic institutions and an international affairs expert who has worked in the higher education sector as tenured professor and senior administrator. He has been the Permanent Representative of the Community of Sant'Egidio to the United Nations and the United States since 1992. Dr. Bartoli has been the Dean of the Seton Hall University's School of Diplomacy and International Relations since 2013. Under his leadership the School reversed seven years decline in enrolment; overcame a name change and significant structural transition; established three new centers (on Peace and Conflict Studies; UN and Global Governance Studies; and on Emerging Powers and Transnational Trends); launched the Sergio de Mello Chair in Post-Conflict Reconstruction in relation to the new certificates in Post-Conflict State Reconstruction (both in person and online) and in UN studies. Dr. Bartoli, in conversation with the faculty, developed a vision for the new School of Diplomacy and engaged students leadership in the process; restructured job descriptions to maximize flow and efficiencies; realigned the School in the context of the university.

Prior to his role at Seton Hall, he served as the Drucie French Cumbie Chair of Conflict Analysis and Resolution at the School for Conflict Analysis and Resolution (S-CAR) at George Mason University since 2007. He was the Director of the Institute for Conflict Analysis and Resolution (ICAR) since 2009, and its first Dean since 2011, when the Institute became School under his leadership. He was able to balance the School's budget addressing its structural deficit with a series of innovative initiatives including the Center for Narrative and Conflict Resolution, the Center for Peacemaking Practice, the Center for the Study of Gender and Conflict, the Program on History Memory and Conflict Resolution, the Genocide Prevention Program and the Insight Conflict Resolution Program.

Before joining the S-CAR faculty, Dr. Bartoli worked at Columbia University through the Italian Academy for Advanced Studies of which he became the Deputy Director. While at Columbia he founded and directed the Center for International Conflict Resolution (CICR) at the School of International and Public Affairs (SIPA) where he remains a Senior Research Scholar at the Saltzman Institute on War and Peace Studies (SIWPS). While at CICR, he held the chair of the Columbia University Seminar on Conflict Resolution; he also conceived and launched the Master in Negotiation and Conflict Resolution.

Dr. Bartoli has served in numerous other peacemaking processes, including in Mozambique (1990–1992), Guatemala (1995), Algeria (1995), Kosovo (1998), Burundi (1999-2000), Democratic Republic of the Congo (1996-current), Casamance (1994- current). Dr. Bartoli was a two-time participant in the U.S. State Department's testimony on Religious Persecution Abroad before Congress. He has been part of the US Department of State Working Group on Religion and Foreign Policy since 2012.

Dr. Bartoli oversaw the development and implementation of CICR and S-CAR's successful interventions in Burma/Myanmar, East Timor, Colombia, Iraq and the African Great Lakes Region. He has worked in the field with each of these programs, as well as responded to partners' requests from countries such as Ivory Coast, Morocco, South Africa, Australia, Kenya, Ethiopia, Lebanon, Italy, Syria, Burundi, Uganda, DRC and Tanzania. He has worked for and collaborated with both public- and private-sectors partners such as the United Nations, the World Bank, the Global Coalition to Prevent Armed Conflicts, the Ford Foundation, the Hewlett Foundation, the European Union, Parliamentarian for Global Action, and the governments of Norway, East Timor, Portugal, Sweden, Poland, and Switzerland. He also raised several million dollars to support CICR and S-CAR's research and program activities.

Prior to his coming to the USA, Dr. Bartoli served as the President of the Unità Sanitaria Locale (USL) 7 in Rome; founded and run the Centro di Studi e Programmi Sociali e Sanitari (CSPSS); and taught at the Università di Tor Vergata Roma Tre.

TEACHING

Dr. Bartoli has taught a number of courses at Columbia University's School of International and Public Affairs (SIPA), as well as other higher educational institutions such as Georgetown University, University of Siena, Universita's Cattolica di Milano. Those courses were frequently initiated by him and then taught by him and other colleagues. At both Mason and Seton Hall he continued to teach courses at all levels while Dean.
