## STUDENT ACKNOWLEDGEMENT

2. I understand and agree that any protest or other public demonstration must be respectful of the University's Catholic mission.
3. I understand and agree that participation in any student protest or other public demonstration is limited to enrolled students and that individuals who are not students may not participate and are subject to immediate removal from University Property and/or criminal charges.

I understand and agree that signs associated with the student protest or public demonstration cannot be affixed to or displayed on University property, including trees, lampposts, buildings, benches, and the like. No materials associated with the event may be left on University property following the event and shall be removed and safely disposed of by the participants. Signs may not be sized or placed in such a way that they obstruct vehicular or pedestrian traffic.
5. I have read, understand, and agree to follow the University's Chalking policy as stated in the [Student Organizations Policies, University Standards & Conduct Expectations](#) (see section: Advertising, Publicity and Posting Procedure).
6. I understand and agree that any flyer, literature, or other material distributed prior to, during, or after the student protest or other public demonstration must adhere to this Student Protest Policy as well as all University policies, rules and regulations.
7. I understand and agree that temporary structures are not permitted on campus due to health and safety concerns, such as local and state health, safety, and fire code regulations. Temporary structures include, but are not limited to, outdoor structures, tables, monitors, and tents, monitors.
8. I understand that the University will assign Security of the number and type the University deems appropriate based upon the size and nature of the student protest or other public demonstration. The purpose of Security is to prevent any interference with the event and to monitor adherence to this policy and applicable University policies and regulations.
9. I further understand and agree that the student protest or other public demonstration cannot disrupt normal University operations, exceed building and/or reasonable outdoors site capacities, or cause noise or other disturbances.
10. I understand that any violation of the Student Protest Policy or the permission granted will result in disciplinary action, up to and including immediate suspension pending hearing and/or expulsion from the University.
