

SUMMARY ANNUAL REPORT

For Seton Hall University Welfare Benefit Program

This is a summary of the annual report of the Seton Hall University Welfare Benefit Program, EIN 22-1500645, Plan No. 505, for period 01/01/2024 through 12/31/2024. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Seton Hall University has committed itself to pay certain self-insured Prescription Drug and Health Flexible Spending Account claims incurred under the terms of the plan.

Insurance Information

The plan has contracts with Cigna Health and Life Insurance Company and Affiliates, Fidelity Security Life Insurance Company, Delta Dental of New Jersey, Inc., Alpha Dental Programs, Inc., Standard Insurance Company, Evernorth Care Solutions, Inc., and Cigna Health and Life Insurance Company to pay Medical, Dental, Vision, Life Insurance, Long-term Disability, Accidental Death and Dismemberment, Employee Assistance Program, Critical Illness, and Accident claims incurred under the terms of the plan. The total premiums paid for the plan year ending 12/31/2024 were \$24,454,193.

Because they are so called "experience-rated" contracts, the premium costs are affected by, among other things, the number and size of claims. Of the total insurance premiums paid for the plan year ending 12/31/2024, the premiums paid under such "experience-rated" contracts were \$1,623,974 and the total of all benefit claims paid under these contracts during the plan year was \$2,522,599.

SUMMARY ANNUAL REPORT

For Seton Hall University Retirement Plan

This is a summary of the annual report Form 5500 Annual Return/Report of Employee Benefit Plan for Seton Hall University Retirement Plan, EIN 22-1500645, Plan No. 003, for period January 1, 2024 through December 31, 2024. The Form 5500 annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA). Your plan is a single-employer defined contribution plan.

Basic Financial Statement

Benefits under the plan are provided by insurance and a trust fund. Plan expenses were \$33,089,821. These expenses included \$205,517 in administrative expenses, \$32,829,798 in benefits paid to participants and beneficiaries, and \$54,506 in other expenses. A total of 3,014 persons were participants in or beneficiaries of the plan at the end of the plan year, although not all of these persons had yet earned the right to receive benefits.

The value of plan assets, after subtracting liabilities of the plan, was \$691,014,580 as of December 31, 2024, compared to \$628,119,495 as of January 1, 2024. During the plan year the plan experienced an increase in its net assets of \$62,895,085. This increase includes unrealized appreciation and depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$95,984,906, including employer contributions of \$8,385,069, employee contributions of \$8,403,592, other contributions of \$4,669,327, earnings from investments of \$73,806,560, and other income of \$720,358.
